



# **AMBASSADOR REWARD CARD SERVICE AGREEMENT**

IN CONSIDERATION FOR THE PRIVILEGE OF BEING ISSUED A TRANSPONDER (RFID TAG) AND A GREEN CARD, THE USER AGREES TO THE FOLLOWING CONDITIONS.

1. THE DETROIT INTERNATIONAL BRIDGE COMPANY OR THE CANADIAN TRANSIT COMPANY (THE BRIDGE COMPANY), IS AUTHORIZED TO CHARGE TO MY CREDIT CARD THE AMOUNT OF \$150.00 IN U.S. DOLLARS AT THE TIME AN ACCOUNT IS OPENED.
2. I AUTHORIZE THE BRIDGE COMPANY TO KEEP MY SIGNATURE ON FILE. I FURTHER AUTHORIZE THE BRIDGE COMPANY TO REPLENISH MY ACCOUNT THE AMOUNT OF \$150.00 IN U.S. DOLLARS WHEN MY BALANCE DROPS TO \$25.00 U.S.
3. TRANSPONDERS REMAIN THE PROPERTY OF THE BRIDGE COMPANY AND ARE VALUED AT \$10.00 DOLLARS U.S. FUNDS. IF MY TRANSPONDER IS LOST, STOLEN, OR DESTROYED, I UNDERSTAND THAT THE AMOUNT OF \$10.00 WILL BE AUTOMATICALLY BILLED TO MY ACCOUNT. IF MY TRANSPONDER AND OR GREEN CARD IS LOST OR STOLEN, I AGREE TO NOTIFY THE BRIDGE COMPANY IMMEDIATELY SO IT CAN BE DEACTIVATED; OTHERWISE, MY ACCOUNT WILL CONTINUE TO BE CHARGED. *A LIMIT OF ONE CARD AND ONE TRANSPONDER (RFID TAG) WILL BE ISSUED PER ACCOUNT*
4. THE AMBASSADOR REWARD CARD ALLOWS THE USER A DISCOUNT ON TOLLS AND THE ABILITY TO PURCHASE FUEL AT A DISCOUNTED PRICE. THE USER MAY ALSO USE THE AMBASSADOR REWARD CARD TO MAKE PURCHASES AT THE DUTY FREE STORES LOCATED AT THE AMBASSADOR BRIDGE.
5. THE BRIDGE COMPANY RESERVES THE RIGHT TO CANCEL AMBASSADOR REWARD CARD PRIVILEGES.
6. THE UNDERSIGNED CONFIRMS AND AGREES WITH THE BRIDGE COMPANY THAT HE OR SHE MEETS THE ABOVE TERMS AND CONDITIONS AND AGREES TO ALL ITEMS AS STIPULATED IN THIS DOCUMENT. UNTIL FURTHER NOTICE THE BRIDGE COMPANY WILL AUTOMATICALLY CHARGE THE COST OF ALL FUTURE REPLENISHMENTS TO THIS CREDIT CARD ACCOUNT. FRAUDULENT MEANS USED TO OBTAIN A TRANSPONDER WILL RESULT IN THE IMMEDIATE CANCELLATION OF PRIVILEGES WITHOUT A REFUND AND ANY OTHER SUCH LEGAL ACTION AS THE BRIDGE COMPANY DEEMS NECESSARY.
